HOW MUCH IS THE ROMANIAN VIGNETTE (ROVINIETA)?

Anyone driving on the Romanian roads must, according to law, (Government ordinance no. 15/2002 on the introduction of a tax for using the national road network in Romania, and ordinance no. 769/2010 on the approval of Methodological Standards for the toll levied on national road network in Romania) pay a road toll called rovinieta. Its price is set according to the vehicle category (A, B, C, D, E, F, G, H) and the period of validity (1, 7, 30 or 90 days, or 12

In order to find out exactly the price of an online vignette, please read the following information:

d) Category D – freight vehicles with 7.5 t less than MATW less than 12.0 t

e) Category E - freight vehicles with MATW over or equal to 12.0t, with up to (including) 3
axles
1 day – 9 Euros;
7 days - 36 Euros;
30 days - 72 Euros;
90 days - 206 Euros;
12 months - 720 Euros.
f) Category F - freight vehicles with MATW over or equal to 12.0t, with at least (including) 4
axles
1 day - 11 Euros;
7 days – 55 Euros;
30 days - 121 Euros;
90 days - 345 Euros;
12 months - 1.210 Euros.
g) Category G – vehicle for the carriage of passengers with more than 9 seats (including driver)
and maximum 23 seats
1 day - 4 Euros;
7 days - 20 Euros;
30 days - 52 Euros;
90 days - 120 Euros;
12 months - 320 Euros.

h) Category H – vehicles for the carriage of passengers with more than 23 seats (including driver)

    1 day - 7 Euros;
    7 days - 35 Euros;
    30 days - 91 Euros;
    90 days - 210 Euros;
    12 months - 560 Euros.
```

Note! Drivers who do not have a valid Romanian vignette can be subject to fines of up to 4,500 lei.
